By signature of the contract, the undersigned agrees to pay the school the required fees as specified in this contract. A \$100 non-refundable deposit is due with this contract and will be used toward the first session's tuition.

- **Tuition for sessions 1 and 2 is due May 19<sup>th</sup>.**
- **Tuition for sessions 3 and 4 is due by June 9<sup>th</sup>.**
- **Tuition for session 5 is due July 7<sup>th</sup>.**

A penalty fee of \$25 will be assessed on all returned checks.

**Late Payment/Late Entry Fee:** Payments or registration received after payment deadlines will be assessed a \$25 fee.

**Change Fee:** Additional weeks, switching weeks, or dropping weeks will be assessed a \$25 late entry fee. I agree to pay a \$25 fee for each change made after Summer Camp begins.

**Trial Period For Students New to TMA:** Parent understands and acknowledges that some children may not be ready, emotionally, developmentally, or otherwise, to participate effectively and successfully in The Montessori Academy Summer Camp program. Accordingly, notwithstanding anything herein to the contrary, Parent understands and agrees that the first Week of the child's enrollment and participation in The Montessori Academy Summer Camp program shall be on a "trial" basis. At the end of the trial period, if Parent and The Montessori Academy (through its Assistant Head of School and input from staff) mutually agree that the student is ready and that it is in the child's and The Montessori Academy's best interest to continue, the child shall remain in the program. If, on the other hand, Parent or The Montessori Academy, or both, conclude after the one week trial period that the child should not continue in the program, this contract will terminate and Parent shall have no obligation for further payment, over and above the first week's tuition. Further, in such event, any payment over and above the first week's tuition may be refunded to the Parent if the Contract is terminated during or at the end of the one week trial period.

**Late Pick-Up:** Children picked up after 3:30 p.m. will be assessed a \$5 late fee for the first 15 minutes, \$10 for 16-45 minutes. For any time 45 minutes beyond the scheduled drop off or pick-up time, a \$1 per minute charge will be added to the \$10 fee. These fees will also be in effect for any early drop-offs for which there is no Extended Day contract. Extended Day is available for your child until 6:00 p.m. with an Extended Day contract or by approved pre-arranged drop-in. Parents picking up children after 6:00 p.m. will be assessed the following late fees:
